



How this affects your energy bills

An average household would need to spend £1,657 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could save £440 per year if you complete the suggested steps for improving this property's energy rating.

Estimated energy needed in this property is:

- 10,939 kWh per year for heating
- 3,256 kWh per year for hot water

Impact on the environment
