



## How this affects your energy bills

### Step 1: Increase loft insulation to 270 mm

### Step 4: Solar photovoltaic panels, 2.5 kWp

Typical installation cost	£3,500 - £5,500
Typical yearly saving	£544
Potential rating after completing steps 1 to 4	83 B
