
Properties can be let if they have an energy rating from A to E.

# **Energy rating and score**

Properties get a rating from A (best) to G (worst) and a score. The better the rating and score, the lower your energy bills are likely to be.

#### Primary energy use

The primary energy use for this property per year is 263 kilowatt hours per square metre (kWh/m2).

### How this affects your energy bills

An average household would need to spend £1,795 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could **save £715 per year** if you complete the suggested steps for improving this property's energy rating.
